CURRICULUM UPDATE

Dr. Rullan informed the audience that the Business Advisory Committee met to discuss future opportunities for students in Career and Technical Education, the STEM Academy, and work-based learning opportunities. Ryan Vollmuth, chairperson for the committee, is collaborating with the Chamber of Commerce to build relationships and ensure that every student has a Student Career Plan that will reflect short and long term career goals.

The Child Development Course and teacher Nancy Silvestrini have been approved through Adelphi University's Ruth S. Ammon School of Education to provide students with the opportunity to earn college credits and place them on track to earn their Childhood Development Associate Credential.

Items discussed included the Willetts Creek remediation, bond work for phases II and III, security vestibule plan approval, a 5K run scheduled to take place on July 1, 2018 in memory of former student Joseph Wood, the Westbrook fire inspection, and inspections at other school buildings, which will be done the week of June 11.

Safety Committee: Mike Zotto reported on the meeting held 5/16/2018. A representative from the Suffolk County Police Department will meet with the administrative team on June 26 to discuss Emergency Response Plans and to plan for building security audits. The committee decided to also engage A+ Technologies to audit building facilities and protocols. Other items discussed were locations of security cameras; the use of armed guards and/or metal detectors; the hiring of a lead guard at the high school; professional development to address topics such as active shooter, *Stop the Bleed*, and DASA/LGBTQ; high school closed campus; roof blue lights to alert those outside the building to seek shelter; visible badges for students during the school day; phones with outside connections near AEDs; and an upgrade to the security fleet of cars.

Committee on Special Education: Annmarie LaRosa reported on the meeting held on 6/7/18. Items reviewed included CPSE/CSE placements for the month and BOCES graduation.

School Board/Student Liaison Committee: Kevin O'Connor reported on the meetings held on 5/30/18 for Udall Road and 6/6/18 for Beach Street. On 5/30/18 Mr. O'Connor and Mr. Michaluk met with Udall Student Council officers, their advisors and Dr. Marquardt. Each member of the committee spoke about the different events the council hosted or attended, including a leadership conference at Sayville Middle School, a food drive at Thanksgiving, a holiday giving tree, a volleyball tournament that raised \$1,200 for the Lion-Heart Foundation, a valentine thank you, Easter Baskets for United Cerebral Palsy, and a pep rally for the eighth graders who are excited about graduation.

On 6/6/18 Mr. O'Connor and Mr. Michaluk met with the Beach Street Student Council. Like the Udall council, the students at Beach showed great interest in the operation of the district. Students started the year by selling discount cards to help fund events for the Beach Street Student Council. They organized a clothing drive to benefit the Gerald Ryan Outreach Center, helped run the pep rallies, a talent show, a ping pong and volleyball tournament, a breakfast for the Beach Street Honor Society and purchased tee shirts for fifth graders entering Beach Street next year. Both Mr. O'Connor and Mr. Michaluk discussed the role of the school board and briefly discussed the budget and its impact on the schools.

Health and Wellness Committee: Mike Zotto reported on the meeting held on 5/21/18. Items reviewed included the 2018 Color Run to be held October 21 at West Islip High School; mindfulness training and programs; and iGeneration challenges. The committee approved funding posters to minimize excessive social media use, and suggested sharing the "13 Reasons Why" Netflix show discussion items with the community. Other programs were also discussed, including nutrition, yoga, book recycling, etc. The first two meeting dates for the 2018-2019 school year are Tuesday, September 18 and Wednesday, October 17.

Mrs. Burns reminded the audience that moving up ceremonies will take place over the next two weeks. West Islip High School graduation will take place at 9:00 a.m. on June 23, 2018. Due to summer bond work, the middle schools will not be accessible; further information is forthcoming. Due to testing and end-of-year activities, there are schedule changes for buildings which is posted on the school website.

The July 3, 2018 Board meeting will take place in the Paul J. Bellew auditorium.

NOTICES/REMINDERS:

Mrs. LaRosa spoke about the second annual Thirst Project Gala that took place in May. Over \$100,000 has been raised to build wells in underdeveloped nations in all parts of the world by West Islip High School students and advisor Paola Nilsen, and they have been recognized as raising the most amount of money in the nation. The first annual West Islip Thirst Project Charity Golf Tournament will take place on Monday, July 30. Information is on the district website.

Mr. Gellar acknowledged all the humanitarian efforts throughout the district, including Common Hope under the guidance of Noreen Matthews.

The following residents wished to speak during an “Invitation to the Public”:

Mrs. Doreen Hantzschel, 1129 Jefferson Avenue, West Islip - Mrs. Hantzschel thanked Mr. Zotto for his years of service on the Board of Education and then spoke about “Safe Space” stickers on classroom doors at the high school that she feels does not represent all protected classes, as they should. Mrs. Hantzschel also inquired as to the status of hiring armed guards; Mr. Gellar advised that information is still being gathered.

Mrs. Robin Mueller, 845 Keith Lane, West Islip - Mrs. Muller expressed gratitude for the ASL program but feels it would be beneficial to expose sixth grade students to ASL in the exploratory rotation. Mrs. Burns advised that ASL has not been offered to sixth graders since the 2008-2009 school year and it is not the district’s intention to eliminate ASL from the curriculum.

Ms. Gwyneth Harrell, 34 Butler Street, West Islip - Ms. Harrell feels ASL should be offered in sixth grade to assist in students’ ability to find their college and career path sooner. Mrs. Burns advised that the seventh grade ASL class has not reached the class limit for next year so students may still enroll; she advised that all colleges do not accept ASL courses for college requirements.

Mrs. Rochelle Cascio, 1523 Madison Avenue, West Islip - Mrs. Cascio shared her concerns about the class size of Ms. Abelson’s third grade class at Manetuck. Mrs. Cascio would like an inclusive setting offered at Manetuck, and asked the Board and administration to add another fourth grade section.

Mrs. Erica Lattuga, 1661 Fairfax Avenue, West Islip - Mrs. Lattuga shared her concerns about the class size of 26 students in Ms. Abelson’s third grade class and the experience this year has had on many third graders. Mrs. Lattuga would like an additional fourth grade section for the 2018-2019 school year.

Mrs. Christie Corbett, 920 Ocean Avenue, West Islip – Mrs. Corbett thanked Mrs. Burns and Mr. Gellar for acknowledging her letter regarding the many challenges the third grade class at Manetuck has faced. Mrs. Corbett requested that the district consider the needs of the whole child in this diverse group of students.

Mrs. Tina Tomasello, 899 Fire Island Avenue, West Islip - Mrs. Tomasello shared reasons a fourth grade section should be added for the 2018-2019 school year at Manetuck.

Faith Yusko, 68 Lawn Avenue, West Islip – Faith Yusko is a high school alumni who expressed concern that the ASL has not been treated the same level as other languages. Mrs. LaRosa explained that the district supports the entire world language department, including ASL, and would not be phasing out the language.

Heather Aronson, 36 Gridley Street, West Islip – Heather is a 2012 graduate of West Islip and requests that ASL be offered as an elective for sixth grade students. Mrs. LaRosa explained that due to attrition in upper level sections, the district has fewer students taking ASL overall, but will not be eliminating ASL.

Mrs. Tara Ardizzone, 164 Fiddler Place, West Islip – Mrs. Ardizzone asked that the district reconsider fourth grade class size at Manetuck Elementary and felt the social emotional needs of the students are more important than academic performance. Mrs. Ardizzone also felt that the district could benefit from a reading/writing program that could meet the needs of the students.

Motion was made by Ron Maginniss, seconded by Kevin O'Connor and carried when all Board members present voted in favor to adjourn to Executive Session at 9:37 p.m. for the purpose of discussing personnel, negotiations, and/or litigation.
