Good evening, phase two of the district's continuity of instruction plan started today. It includes the introduction of new coursework and grade level curriculum K-12 as well as increased opportunities for students to interact with your teachers a guidance document for students and parents outlining that plan was posted on the district website on Monday parents that have questions in regard to a teacher's plan should address those questions. Teachers continue to collaborate with administrators on a daily basis in regard to the effective implementation of the plan. The plan will be periodically reviewed and if necessary and adjusted purposeful learning experiences and I would like to thank and acknowledge the learning taking place K-12. The district's leadership and the district's administrators for their leadership throughout these unprecedented times and to our teachers for their dedicated efforts in supporting the students as a district. The ongoing academic needs of our students, we have figuratively moved mountains in the past three weeks and while challenges no doubt will continue to present themselves. So we'll find solutions and as a result, our instructional practices will be stronger when our students and staff return to the classroom. The New York State Education Department posted their

participation rate status report for all school districts as required by ESSA, Manetuck Elementary School, Oquenock Elementary School and Beach Street Middle School have been identified on the list with participation rates on the test in the bottom 10% of the state this unfortunately puts those three buildings on a list that requires participation. It should also be noted that Bayview Elementary School and Paul J Bellew and Udall Road Middle School were flagged and are in jeopardy of being on the list for the 2020-2021 school year. So together as a district for the three through eight testing process, we are going to be working to re-engage our students with the assessment process will utilize those results to ensure that our academic programs are sound and that our students are receiving the correct supports that they need in order to perform at grade level standards.

If we cannot improve those engagement rates. Do I have a question just a question what is the next step in terms of their state consequence?

On March 31 an online meeting took place, committee members present were Annmarie LaRosa, Paul Michaluk, myself other board members in attendance Steve Gellar, Richard Antonello, Tom Compitello and Peter McCann. Administrators present were Superintendent Burns, Assistant Superintendent for Business, Mrs. Pellati and Brian Taylor Executive Director of Human Resources. The purpose of the meeting each month is to discuss pertinent fiscal matters and review the warrants. The meeting was called to order at 7:43. We went through the monthly reports as usual the treasurer's reports for school district funds for February the payroll summary 2020 were presented and accepted by the committee report from March 2020 was presented and accepted by the committee as was the financial statements or February of 2020 presented and accepted by the committee. The system manager audit trail report for February 22 through March 25, and the payroll certification report for March 6 and March 20 were presented and accepted by the committee. We reviewed the following board agenda Finance items approval of the budget transfers were presented and accepted by the committee for approval and for submission to the board for approval the 2020-2021 Affordable Care Act Administration agreement was presented and accepted by the committee. Approval of donations and resolution for CPI Aerostructures who donated a Bridgeport milling machine to the high school technology department valued at \$4,000, approval of Health Services contracts for Bay Shore UFSD in the amount of \$20,197.32 and Deer Park UFSD for \$2,794.50, and approval of the following bid extensions for 2020-2021 for Advantage Music, Best Climate Control Corp., Ideal Fence Corp., and Riddell All-American approval for request for Auditors as well as approval of a proposals for Cullen and Danowski and 2019-2020 change order for LoDuca Associates for \$27,281.00. We had a couple of other items due to school closure the

district began serving grab-and-go lunches and breakfasts on Monday, March 30 feeding 60 children as well as children who couldn't come to the facility. They fed 81 students on Tuesday and 69 on Wednesday. The board also asked about the status of potential lost Revenue during the pandemic and what the runs at the time were But I believe we've gotten an update that at this point and it probably or could change going forward but between five and fifteen percent decrease in our aid, the meeting was adjourned at 7:43.

Good evening, the Buildings and Grounds committee met on March 31, 2020. We started approximately at 7:45 p.m. it was an online meeting members in attendance were a Annmarie LaRosa, Mr. Maginniss myself Mrs. Burns Mrs. Pellati, James Bosse, Richard Antoniello, Tom Compitello and Mr. McCann. We discussed the shutdown due to the Covid-19. Mr. Bosse explained actions taken due to the closure of all school buildings a custodian performs a building check daily to ensure that all mechanical systems are performing correctly, and other tasks such as payroll is addressed, and mail is picked up and delivered twice weekly. Mr. Bosse gave an update as to the status of Phase 4B and Phase 5 bond projects. Despite the school closures, the bidding process will commence shortly, and will likely be conducted in a virtual manner so that work can begin as soon as schools are reopened. Due to the Executive Orders relating to Covid-19, there are limitations to the type of contraction work that can be done, so there may be a delay in the start of some projects. Mr. Bosse gave an update on the PV solar project. A financial evaluation was provided to the Board by the ECG Group comparing the strengths and weaknesses of the final two proposals for the PV solar project - Johnson Control and Noresco. The committee discussed the proposals and requested that Mr. Bosse contact Noresco with questions about how contingencies were to be handled within their proposal. Fire Code compliance inspections were postponed due to the closures related to Covid-19. An extension was submitted by the district and accepted by NYSED. Inspections will proceed when the Suffolk County fire marshal is available. A tent donated by VJ Entertainment was set up in the high school parking lot to facilitate the distribution of meals to eligible families in accordance with one of the recent Executive Orders. The meeting adjourned at 8:15. Thank you.

Thank you Mr. Michaluk, you know, I just want to get back to Mr. Maginniss who has questions about the state budget and if the Foundation Aid is to remain constant for all districts from last year with gaps coming from federal money to help fight Covid-19. potential issues coming

down the road because the governor now has unilateral authority to make changes to the state aid. As the year goes on I believe there are four separate times when he can do so and basically, we are at that point and will be on pins and needles. Also come next year when the government money and the federal government money is not there. Then the state is in theory going to have to make that up. So it will likely be played out over a series of years. Like it was with the G EA and in fact, you know, they're calling this pandemic adjustment. So, you know for us right now, we only lost a small amount of money forward, but I think it's certainly a so we'll see what happens as it goes to discussion. I know there's some recommendation that Mrs. Pellati had in her memo and had talked about adopting of the budget until after the first adjustment date and I certainly think that's a good idea. Mrs. Burns would you care to weigh in on that.

Yes, Mr. Geller. Actually, I had a conference call earlier today with NYSCOSS and Greg Berke and Bob Lowry who are really the gurus up there in Albany. From the perspective the superintendents made it very clear that no one should really move forward with budget adoption until updated aid numbers are posted UNTELLIGIBLE and they are pretty confident that we are not going to see that full reimbursed amount next year right now the economy and the state is just too much in flux. And even if the federal package is a little bit better a district such as ours is unlikely to benefit from it. So they felt that at best we would get half of that amount and some people are confident and think it would be 3/4, but certainly not the full amount as represented in the run that we received yesterday.

Yeah, I agree as I say I think that over a period of time and probably go if best case it will be reimbursed to higher need first and to districts that the government sees. So, okay. Thank you.

The Special Education Committee met on the first of April by conference call. Members present were Mrs. Dowling, Mrs. Morrison, Mr. Maginniss and myself. We discussed CSEs and annual reviews ongoing throughout the district. Then we talked about the learning progress and a couple of minor hiccups but apparently it is going fairly well with the virtual learning program and we discussed alternative placement and new programs for those students that could meet their needs.

Okay, thank you. Mr. Gellar the Education Committee met tonight online at 7:15. Members present including myself were Mr. McCann, Mr. Gellar, Mrs. LaRosa, Mr. Michaluk, Mr. Maginniss, Mr. Compitello, Mrs. Burns and Mrs. Morrison were also present. First item discussed which was highlighted already is the continuity of instruction plan. Phase two of the continuity of instruction plan started today and a copy of the plan was provided to all teachers and reviewed with them by the respective administrators with a guidance document outline. The plan for parents and students was posted to the district website. The expectation for students to complete the assignments engage in daily learning experiences provided to them is emphasized in the plan, mechanisms are in place on the technology platforms being utilized that relate to student access and provide information to teachers usage of various resources. The administrative team is in daily contact with teachers in regard to the implementation of the plan, which will be periodically reviewed to ensure its effectiveness as appropriately necessary and make adjustments. The second item discussed was the NYSED participation rate status report as required by the state approved, Every Student Succeeds Act. The New York State Education Department posted the participation rate status. Manetuck and Oquenock elementary schools and Beach Street Middle School participation rates on the state tests were in the bottom 10% of the state. Principals must create a building participation rate improvement plan that delineates how they plan to increase testing participation rates for the 2020 2021 school year. The testing participation submission to the New York State was originally due to the education department on May 1 but due to the current circumstances, the deadline has been extended. The principals were provided with the information to complete the plans for their buildings. The plan for each building will be submitted to the board of education for approval prior to the submission to the New York State Education Department. It should be noted that Bayview and Paul J. Bellew elementary schools and Udall Road Middle School have been flagged also and are in jeopardy of being officially on the list next year. The meeting ended at 7:35.
