Items discussed included Mission Be "Mindfulness" pilot starting May 5, 2016, the upcoming Title I Grant Audit, ideas to encourage more student participation in AP exams, a summer math program for middle school students who need extra support and the district partnering with Princeton Review for ACT and SAT preparation.

<u>Buildings and Grounds:</u> Kevin O'Connor reported on the meeting held on 4/12/16.
